Jennifer Griffin has been helping chairs transition to the new system.

Finally, our states need to make a better effort to follow their Bylaws and Standing Rules. There were several situations this year that could have been avoided if the states simply followed their Bylaws. Our Parliamentarian Louis William Rose will be addressing this topic at our State Presidents Day as well as his workshop.

I wish to thank everyone whose help has been invaluable during my third year as president. It has been a team effort, and I am indebted to each and every one of you.

NFMC National Conference Milwaukee, Wisconsin – June 19-23, 2018

Ohio Federation of Music Clubs hosted the NFMC Convention in Dayton June 20-24, 2017. Forty four attended from the Northeast Region. Christy Smith, OFMC president, was chair.

The 73rd Federation Weekend of the Northeast Region began on Friday evening, July 7, 2017 with a Meet & Greet dinner in the dining room of Chautauqua Suites & Expo Center, the meeting hotel. It is near Chautauqua Institution, an internationally renowned center for the arts, education, religion and recreation, in western New York state.

The active states in the Northeast Region include Connecticut, Delaware, Indiana, Maine, Michigan, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, and Vermont.

Mary Ellen Nolletti, NFMC Summer Music Center chair, presented an NFMC Certificate of Appreciation to Lois Tamplin, who had served as the NFMC representative to the Chautauqua Summer Music Center for many years. She gave each attendee a Summer Music Center map.

We divided into discussion groups. The Senior Division discussed the inclusion of American music in our club programs. Virginia Kleeberg, NE Region festival chairman, led the Junior Division discussion. The NE Region Bylaws Committee completed its revision of the Bylaws and distributed copies to the members.

The guest speaker for Saturday's luncheon at the hotel was Deborah Sunya Moore, vice president in charge of programming at Chautauqua Institution. She told about the new amphitheater and the many programs that she over sees for the Institution.

On Saturday afternoon, we went to the Institution for a recital given by students in the Summer Music School who had received scholarships from NFMC, states in the region & the Chautauqua Foundation. Thirteen students (7 vocalists, 2 pianists, & 5 instrumentalists including cello, viola, double bass, harp and oboe) gave an outstanding recital. Saturday evening the Chautauqua Opera department and the Chautauqua Symphony Orchestra presented *L'Orfeo* by Monteverdi in the 5,000 seat Amphitheater.

On Sunday morning, we heard the 100-voice Chautuaqua Choir and the Massey Pipe Organ in the church service at the Amphitheater. Some members of the NE Region sang in the choir. Sunday afternoon, the U.S. Army Field Band & Soldiers' Chorus performed. NFMC Young Artist Nick Susi, pianist, presented a concert in Lennā Hall. Following the concert, Nick joined our members for a reception in his honor on the porch of the Recital Hall. IndianaFMC was the host state for the reception. Some members had supper with the Young Artist at the historic Athenaeum Hotel and concluded the day at the Sacred Song service in the amphitheater.

I sent four issues of Northeastern Notes to region members and some NFMC officers. Delaware FMC held their third annual festival in March. They include piano, flute, strings, voice & musicianship. Students have entered the Lynn Freeman Olsen event, and many found the selections were great. They have adult and junior entries.

Mary Jane Timmer, Michigan state representative on the NFMC Board & past president of Michigan Federation of Music Clubs, became the NFMC Federation Cup chair in 2017.

Pennsylvania FMC had their first Festivals Competition this spring. The Competition was open to PFMC Juniors (through age 18), and they had to have participated in the annual Festival program before entering the Festivals Competition. The purpose of the competition is to offer Festival entrants the opportunity to take their music to the next level and compete for monetary awards. There were 2 rounds of competitions - 2 regional competitions & the final round during their state convention. The Pennsylvania applicant, Juliet Jacques, was awarded 2nd place and a prize of \$1,000 in the Wendell Irish Viola Award Competition. In addition, Juliet received the Northeastern Region award of \$250.

Jane Goldstein reported that the Vermont Festival is preparing to move to a new, expanded festival site in New Hampshire. We think that we will be adding new teachers in New Hampshire who judged last year and found festival to be a positive experience for students.

It has been a wonderful idea to hold a business meeting during the NFMC Convention/Conference for the benefit of those members unable to attend the July Regional meeting. During this meeting Elaine Knight, the outgoing SER Vice President graciously thanked all the members for the opportunity to serve. The meeting was turned over to incoming SER Vice President Marcia Chaplin. The goals set for the next several years by the incoming Vice President are to learn about all the sponsored Summer Music Camps in the Southeastern Region. The treasurer now handles the Award Account while the Executive Director maintains the operational accounts. This process works very well and streamlines the treasury management process. In fact, the operations of the general fund have been so efficient that no requests for funds have been requested from our Investments Accounts. As chairman, my first task was to prepare a plan of work which stated my goals and methods. E-mails were sent to state presidents, insuring that NFMC had their correct information. Most importantly the Council Chairman should assist and encourage new and returning presidents and provide them help with the challenges their office brings, as stated in the NFMC Standing Rules: "The State President's Council is organized for the purpose of discussing state activities and the correlation of state and national work". Goal planning and ways to meet those goals were stressed. E-mail messages were sent asking for questions, or problems and tentative solutions were provided. Presidents were encouraged: to **Remind** local clubs to use current information and materials for reports and applications; to **Encourage** participation in opportunities offered by various Federation divisions (even Junior clubs can participate in many programs); to **Investigate** new ideas for membership growth and development; and to **Share** good ideas, information, concerns, website addresses, newsletters, etc. with each other *and with me*.

The Dayton Council Meetings were planned to help both those currently serving as president and those just coming into office. We were honored by greetings from NFMC President, Michael Edwards and First Vice President, Frances Nelson. Discussions were held and informative handouts were distributed about the structures and procedures of NFMC. Time was allowed for presidents to discuss their individual programs, activities and concerns with each other. The Greatest joys expressed were: the great variety of member personalities, making music together, and being able to help young people begin their musical journeys. The greatest problems expressed were ways to recruit and retain new members and working with large groups of diverse people. Council meetings were both educational and informative and hopefully addressed many of the problems encountered by our state presidents.

These achievements occurred or are in process across our country: New senior clubs have been organized and membership seems to be growing in some places; Many creative programs have been developed and Federation competitions and awards are being promoted; Interest in the Junior Division continues to grow and interest in Student programs is improving; Many senior clubs are now tax exempt which benefits their organizations; and most states have internet capabilities and websites.

This officer has endeavored to make Council meetings interesting and enjoyable, to provide information, to educate, inspire and thank all who serve NFMC. It is my belief that State Presidents truly are the Federation's lifeline, and with their strong leadership and dedication, our organization can show new growth and development in the coming year.



#### NATIONAL FEDERATION OF MUSIC CLUBS 2017-2018 ARTS ADVOCACY REPORT

Lee Ann Cummings, Chair Committee Members: Lois Armor (TX), Karen Herndon (SC), Jeannine Morris (OH), Sally Palmer (WA) Dawn Steggerda (IA)

I presented a break out session at the NFMC 2017 Convention in Dayton, OH. About 10 people attended the session. Tips on advocacy dos and don'ts were discussed as well as success stories and experiences.

The National Federation of Music Clubs was a National Partner for the Americans for the Arts 2018 Arts Advocacy Day, the National Arts Action Summit. I appreciate the opportunity to represent NFMC at this annual event, entering its 31st consecutive year. Carolyn Nelson also attended. Arts Advocacy Day is the only national event that brings together a broad cross section of America's cultural and civic organizations, along with thousands of grassroots advocates from across the country. Arts Advocacy Day has been instrumental in advancing key legislative initiatives, including increased funding for the federal cultural agencies and enlightened tax, international, and education policies.

Attendees participated in legislative training sessions, where we learned about the current arts issues on Capitol Hill and how to become effective advocates for increased support of the arts. The 31st annual Nancy Hanks Lecture on Arts and Public Policy was held at the John F. Kennedy Center for the Performing Arts and featured Lonnie G. Bunch III, founding director of the Smithsonian National Museum of African American History and Culture.. Advocates carried the message for increased support of the arts in visits with Members of Congress across Capitol Hill. Carolyn and I also attended the Turnaround Arts Talent Show, a program of the Kennedy Center, featuring performances by participating schools from Illinois, Hawaii, Florida, Wisconsin, Minnesota, Connecticut, Iowa, New York, California, North Dakota, Louisiana, and Washington, D.C.

During visits with the Congressional Delegation of Mississippi, I stressed the importance of preserving tax incentives for charitable giving by protecting the full scope and value of the tax deduction for all forms of charitable gifts, increased funding of the cultural agencies and strengthening arts education.

As of May 17, 2018, I received 15 Arts Advocacy reports from senior clubs representing Arkansas, Mississippi, Pennsylvania, South Carolina, Texas and Virginia. The deadline for submission was April 30. I may receive more in the coming weeks.

Sadly, Lois Tamplin, Northeastern Region committee representative passed away this year. Her term will be filled by Jeannine Morris of Ohio. Carole Flautau (SD) and Sally Palmer (WA) are unable to continue their service on this committee. Dawn Steggerda (IA) will represent the North Central Region. A replacement has not been named for the Western Region.

State Highlights: Pennsylvania: The Towanda Musical Society reports members serving on various boards associated with the arts and members who frequently participate in local theater and musical events. Members attend local school performances and special events associated with the Bradford County Regional Arts Council. The club dedicates at least two programs to local music students and offers several awards and scholarships to local high school seniors.

The exciting announcement by National President Michael Edwards recently that Cellist Zuill Bailey had won a Grammy Award on February 12, 2017 in the category of Classical Instrumental Solo led me to want to check on Michael's comment that, to his knowledge, this was the first Grammy won by an NFMC Young Artist. I was drawn to Mrs. Lucille Ward's history of our Federation – A MUSICAL LEGACY OF 100 YEARS. Toward the back of the book, Mrs. Ward lists the audition winners from the beginning, with the first YA winners, which took place in 1925. The Grammy Awards did not begin until 1959, with the eligibility year's being 1958.

Robert Brownlee won our Piano award in 1958, and though his career was very successful (with many solo concerts throughout the world, plus concertos with numerous symphony orchestras) we could find no record of a Grammy. Dr. Brownlee finished his playing career as a Professor Emeritus at the University of Houston.

Soprano Kathleen Battle gained much acclaim beginning as a Young Artist in 1975 in opera and conerts, but of course she was not known as an instrumentalist. She made the newspapers last year after being fired by the Met twenty years ago but was hired back to present a concert of spirituals, which was highly acclaimed. Of course, her voice was her instrument.

Zuill Bailey won the Young Artist Auditions in 1991 in Philadelphia and has enjoyed a busy career of concertizing and recording through the years.

So it looks as though Michael was right "on the money" in proclaiming that Zuill Bailey was our first Young Artist to be awarded a Grammy! We extend congratulations to Zuill and his family, especially his proud parents Lana Bailey (past President of NFMC) and Zuill, Sr for this fine honor.

Report of the NFMC Representative to the United Nations Department of Public Information 2018 NFMC Conference, Milwaukee, WI

I attended my first DPI briefing entitled **The Global Ageing Population: Impact and Implementation of Agenda 2030**, on June 1, 2017. Agenda 2030 is a result of the UN Sustainable Development Goals agreed on by 193 world leaders in 2015 and implemented in 2016. The SDGs are a 17-point plan to end poverty, combat climate change and fight injustice and inequality. The briefing focused on the third goal, to "Ensure healthy lives and promote wellbeing for all at all ages." The panelists described initiatives that are improving the quality of life for seniors throughout the US. They were proud of the work being done but stressed to all in attendance that more needs to be done, especially at the grass-roots level.

The next briefing I attended was on April 5, 2018. **The Value of Peacekeeping: Stories from the Field** was presented by both civilian and military peacekeepers who shared stories of their work and offered us a glimpse into the struggles, challenges, and triumphs of these remarkable people. We learned that there are over 105,180 personnel working in 15 peacekeeping operations around the world and that currently 123 different countries are contributing uniformed personnel to peacekeeping missions. Peacekeeping operations began in 1948 and since then there have been 71 peacekeeping missions. We learned that a peacekeeping operation is not an army, or a counter-terrorist force, or a humanitarian agency. "It is a tool to create the space for a nationally owned political solution."

I will attend one final briefing this season on May 24. This briefing, entitled **Paving the Way to Road Safety**, was originally scheduled for May 10 but was moved to the end of the month. At each of these briefings I meet representatives from other NGOs. The briefings are most certainly informative and eye-opening, but an added benefit is the ability to network with representatives of other NGOs. There are so many ways NFMC can play a role in the work of the UN as well as other NGOs. I look forward to discussing how best to proceed when I meet with President Edwards and other officers while in Milwaukee.

With regard to the piano NFMC donated in 1985 - you will recall that NFMC marked the 40<sup>th</sup> anniversary of the UN with a gift of a six foot grand piano. When I first started to make inquiries concerning the piano in October of 2016, I was told that the UN Singers had the piano and used it for in-house performances. After further inquiries, I learned in August 2017, that the piano was located in the Dag Hammarskjold Library Auditorium but that the auditorium was closed due to building issues with no plan to re-open it. I was told by the manager of Special Events at the UN that the piano had not been in use for at least 2 years other than one event in July of 2017 when it was moved to another floor, tuned, played and put back. He said that the piano is in disrepair, with an issue with the lid and one of the legs. They would have moved the piano to another location but there was nowhere else in the UN to place it. I received a final message from a member of the UN Music Chamber Club stating that the piano can no longer be relocated and that the Auditorium is permanently closed due to security reasons.

It is an honor to serve NFMC as Representative to the UN DPI and I look forward to continuing in this position.

#### 2018 NFMC ARTS DIVISION REPORT

The Arts Division covers many areas of NFMC opportunities in music. I am excited to report that all eleven of the chairs reported to me with the activity in their musical areas. We welcomed some new chairs to the Arts Division last fall. Sacred Music Chair, Karen Herndon of Ehrhardt, South Carolina and Music in Schools and Colleges Chair, Dr. Liana Valente of Alexandria, Virginia. We were also joined by several new regional chairs, Bill Draper, Joel Adams, Peg Bryan, Lynn McNew, Daryl Jessen, and Brenda Lewis. The returning chairs and the new chairs did an amazing job of encouraging states and clubs to report on their yearly activities. We have 33 individuals working in the Arts Division and THEY ARE THE BEST!!!

The Chamber Music Chair, Lorraine Peery Long announced a total of ten states submitted reports. They were Alabama, Kansas, Kentucky, Mississippi, Missouri, North Dakota, Ohio, Pennsylvania, South Carolina and Texas. 34 Senior Clubs are represented in the report with 70% reporting Chamber Music events performed in their meetings. This year, the most active states that promote Chamber Music were South Carolina and Texas. South Carolina had this status last year as well.

Crusade for Strings Chair, Sherry Pollock had 9 reports from the states of Arkansas, Kansas, Kentucky, Michigan, Mississippi, Missouri, North Dakota, and Pennsylvania. This number is up from the 5 reporting states last year. There were 21 reporting clubs plus 2 student clubs. The scholarships for youth orchestra and summer camps were up to \$23,525 from \$18,825 last year. The financial supported string programs in schools is up from \$500. to \$650. with 1245 volunteer hours. See Sherry's full report for the \$25.00 Regional Club Winners and the \$5.00 Regional Junior Club Winner.

International Music Relations Chair, Dr. Mira Kruja reported that the winners of the 2018 International Music Relations awards are: 1<sup>st</sup> place, \$75.00, Tuesday Musical Club, Pennsylvania with four programs including International Music, 2<sup>nd</sup> place, \$50,00, is Gadsden Music Club, Alabama with an International Music multimedia program on J. S. Bach and G. F Handel, and 3<sup>rd</sup> place, \$25.00 to Dushore Music Club, Pennsylvania with a French vocal and piano music program. See Dr. Kruja's full report for more insight on Dr. Kruja's involvement with promoting international music relations.

Music in Poetry Chair, Margarita Harvey was pleased to report an increase in participation this year. She had four Regions with a total of 45 clubs to report. That is almost double last year's numbers. The South Central and Southeastern Regions tied with a total of 15 Clubs reporting for each Region. Texas led the states with 10 clubs reporting and South Carolina was a close 2<sup>nd</sup> with 8 Clubs reporting. She extended a hearty "Bravo" to the Regional Chairs who have worked to promote the poetry area of the Arts Division.

Music in Schools and Colleges Chair, Dr. Liana Valente received reports from the North Eastern, South Central, and South Eastern regions. The Western region chair noted that no reports were submitted from her states and no report was received from the North Central region chair. Dr. Valente referred to the Competitions & Award chart that is invaluable to students, teachers, and supporters of musicians across the country with the newly updated NFMC website. It is easier to access information about scholarship opportunities. Dr. Liana urges all state presidents to appoint a State Music in Schools and Colleges Chair so that the clubs good work can be reported. She states that communication is essential. Please check out her full report for the states activities in the area of Music in Schools and Colleges.

Choral Music Chair, Victor Klimash reported that it is fitting that The National Federation of Music Clubs recognizes the important history of choral singing in America, and supports its future. He received reports from 8 states, which included Arkansas, Kansas, Louisiana, Missouri, Mississippi, Pennsylvania, South Carolina, and Texas. There was a suggestion that the NFMC Choral Report Form AR 8-2 be amended to include space to type in more information on scholarships awarded by each club, and adding a request for copies of programs. Victor also recommended that if a cash award is available for Choral Music, that it be equally divided between the two clubs which have newly-formed ensembles: The Canton Music Study Club of Mississippi and The Melody Club of Dallas, Texas.

The Together We Sing report was submitted by Barbara Murry, who is helping Carole Flatau finalize this year of reporting. Due to health issues, Carole will be resigning this chair. There were reports received from 6 states. Arkansas, Kansas, Kentucky, Mississippi, Pennsylvania, and Virginia. A total of 29 Senior Clubs reported using the Together We Sing Songbook. Barbara stated that Carole has done an outstanding job in making this book user-friendly. We all share Barbara's thoughts that walking in Carole's shoes will be a challenge, but her hard work and dedication needs to be remembered and honored by making sure the songbooks are published and available for all of us to enjoy!! I think Carole Flatau's words from last year still ring true "by saying that "Together We Sing" provides the opportunity for NFMC members to meet our responsibility of ensuring that the songs of our history and our heritage do not simply fade away and die." Music Outreach Chair, Arlene Lewis received reports from 56 clubs giving at least 1000 hours for the club award and 27 individuals that gave 100 or more hours. Awards are not given to the same individual or club in consecutive years. This years \$150.00 award will be given to the Birmingham Musical of Michigan and the individual award of \$150.00 will be given to Nina Flanigan of Michigan. See Arlene's full report for a list of participating clubs and individuals.

Karen Herndon, Sacred Music Chair, received reports from 7 states representing 34 clubs. Reporting states were Kentucky, Mississippi, Ohio, Pennsylvania, South Carolina, Virginia, and Arkansas. The Sacred Music Chair is recognizing 7 clubs for outstanding Sacred Music Programs. They are: Dushore Music Club and Williamsport Music Club of Pennsylvania; Orangeburg Music Club and The Music Club of Greenville of South Carolina; and Portsmouth Music Club, South Hill Music Club and Thursday Morning Music Club of Virginia. There were reports of 66 NFMC members who have served as church musicians for more that 50 years. That is an increase from the 52 reported last year. Keep up the good work church musicians! Read Karen's full report for a complete list of the 66 church musicians who have served over 50 years.

Helena Meetze submitted a National Music Week Essay Contest Report. It is still too early to do National Music Week reporting. 17 states had declared winners with a total of 86 essays. \$850.00 was awarded in increments of \$50.00 to the winner in each state. The number of participating states was down from last years 20 and the

number of essays was down from last year's 105 essays. Each winner received a certificate of merit and a congratulatory letter. The student's teacher also received a certificate and letter. The state president was sent a letter of congratulations. The 17 winning essays and photos of the students were published in the spring issue of "Junior Keynotes". Helena gave special thanks to the three regional chairs, Mary Ellen Ulmer, Julianne Edwards and Jan Hansen. Please refer to Helena's full report for a complete list of the states and their winners. Opera Chair, Margaret Ulmer recognized her 5 regional chairs, Norma Alexander, Connie Craig, Donna Gerber, Jan Stoffel and Judy Prescott. Reporting states included Missouri, Texas, North Carolina, Alabama, South Carolina, Virginia, Florida, Ohio, Pennsylvania, and North Dakota. This represents 51 clubs from the 10 states. Margaret still states that OPERA IS ALIVE AND GREAT!

As I close my report for this year, I want to share a thought that I read in Margarita Harvey's report. She said that "the seeds have been planted, now let us collectively nurture them to fruition". YES! That's what we do. My words from last year are still true. Promoting music binds us together from across this nation and beyond. I want to add a special note here in honor of Carole Flatau. From the first time I meet Carole, I knew she had a PASSION for folk/grass roots music. She glowed when she talked about it. It has been my privilege to know her and work with her over the years. Thank you, Carole! Every chair in this division has worked to increase music awareness in their area. Keep doing music! Keep doing what you love! The Chamber Music Department is proud to announce a total of ten states that submitted reports. The following states were represented: Alabama, Kansas, Kentucky, Mississippi, Missouri, North Dakota, Ohio, Pennsylvania, South Carolina and Texas.

The states comprised of thirty-four (34) Senior Clubs that sent reports. Approximately 70% of these clubs reported Chamber Music events which were performed in their meetings by guests or respective members. I am pleased to report an increase in participation in 2018. When I began my tenure as National Chair, I reported in 2016 that only three out of five Regions with a total of 16 Clubs nationally reported.

This year, I had four Regions with a total of 45 Clubs report. The South Central and Southeastern Regions tied with a total of 15 Clubs reporting for each Region. As for States, Texas led with 10 clubs reporting, and South Carolina was a close 2<sup>nd</sup> place with 8 Clubs reporting.

Guest readers are invited and some read their original poems. A few Clubs take pride in studying or attending poetic dramas, or focusing on a poet, a style or theme. The members of one Club attended a performance of a Shakespeare play. Also, one Club sends out a newsletter regularly featuring poetry by various authors.

Some Chairs have met with some resistance or disappointment, but I encourage them to share what others are doing. My report shows Clubs around the nation are creatively promoting and enjoying Music in Poetry. The seeds have been planted. Now let us collectively nurture them to fruition.

Arts Division, Music in Schools and Colleges Report NFMC 2018 Conference, Milwaukee, WI

Music in Schools and Colleges remains an active an important part of NFMC. All who read this report should be excited by the work being accomplished in our states to support students of all ages as they pursue music as either a profession or avocation while bringing a variety of music to their communities. With the newly updated NFMC website, club officers and members are now better able to access information about scholarship opportunities and share this information with area teachers quickly and efficiently. And we must recognize that Dr. Keck's compilation of the yearly Competitions & Award chart is invaluable to students, teachers, and supporters of musicians across the country.

The Chair received reports from North Eastern, South Central, and South Eastern regions. The Western region chair noted that no reports were submitted from her states and no report was received from the North Central region chair. The North East region chair reported receiving information from 31 senior club reports, eclipsing the number of reports received in the South Central (13 Senior club reports and 1 Junior club report) or Southeastern regions (6). I hope to meet with all of the regional chairs while in Milwaukee to discuss how we can better stay connected with each other and our state organizations.

From the reports received it is clear that many states have active clubs that support and promote young (K-12) musicians as well as college-aged musicians. Competitions are held throughout the country, sponsored by individual clubs or states. In Florida, the Jeanie/Stephen Foster competition was held for the 67th time; this competition not only awards monetary prizes to winners and runners-up, but offers performance opportunities throughout the state for the winners. And Florida's Junior Festival saw more than 1400 talented young musicians compete this year. Many clubs sponsor concerts that feature young aspiring performers, giving them invaluable experiences performing before live audiences. Four clubs in Texas and three clubs in the SE region invited NFMC Young Artists to perform at their state meetings or a club meetings. Some senior clubs sponsor exceptional performances for their communities at no cost. For example, in Virginia the Woodbridge Music Club presented a free concert in February by the US Army Soldier's Chorus in conjunction with the Forest Park High School Choir. Then in April, they hosted 2017 NFMC Young Artist Competition Winner Andre Chiang in a free concert held at a local church in their community. And two clubs in Texas, the Marshall Music Club and the Carthage Music Club, each created successful and sustainable music programs in area schools where music was not available.

I firmly believe that Music in Schools and Colleges plays a vital role in the lives of thousands of students each year. I encourage all State Presidents to promote the competitions and awards available throughout their states and to seek assistance from the regional chairs and the national chair for advice concerning the national awards. I would like to see all regional chairs contact their state presidents immediately following the national conference in order to assist as clubs begin planning for the year ahead. And I urge all state presidents to appoint a State Music in Schools and Colleges Chair so that your good works can be reported. Communication is essential and with the relative easy accessibility of email and phones there should be no breakdown in our conversations to strengthen and support music in our communities.

#### National Federation of Music Clubs Choral Music Report 2018

Choral Music has a unique place in the panoply of art forms. It is available to everyone of any station of life, at any age of life, of any religious persuasion, of any political stripe, and any gender. Its themes are universal, and its execution requires both personal effort and team work. The fellowship and exhilaration shared in performance create a bond with audiences past and present. Those who sang or heard the first performance of a choral work are inextricably bound through time to those who sang and heard the most recent performance. It is fitting that The National Federation of Music Clubs recognizes the important history of choral singing in America, and supports its future.

**Arkansas:** The Music Club of Hot Springs and the Foreman Thursday Club both support choruses that perform within their communities.

**Kansas:** Three of the twelve clubs within the state have choral ensembles that regularly perform.

**Louisiana:** The Music Club of Baton Rouge provides twelve college scholarships, and sponsors a chorus that performs over two dozen concerts within the community. In addition, this is the third year that an ensemble of women's voices, made up of members has performed a major work during the holiday season.

**Missouri:** The Evening Etude Music Club and Perry Musique both have members who perform in community choruses.

Mississippi: This year The Canton Music Study Club has organized chorus for the first time. (Ai tutti bravi!)

**Pennsylvania:** Both The Dushore Music Club and The Tuesday Music Club have provided significant financial aid to music students. In addition, both those clubs are joined by Lakeview Music Club and Musical Art Society in participation by members in choral activities.

**South Carolina:** Three clubs from Greenville, Crescent Music Club, Greenville Women's Music Club, and The Music Club of Greenville were joined by Eau Claire Music Club in providing scholarships.

**Texas:** Nine clubs have a standing chorus (one of which was formed this year), many of which perform outside club activities. Seven clubs provided scholarships as well: The Carthage Music Club, The European Music Club of Fort Worth, The Music Club of Marshall, The Harmony Club of Fort Worth, McAllen Music Club, New Braunfels Music Study Club, and The Vernon Musicians Club.

It was suggested that the NFMC Choral Report Form AR 8-2 be amended to include space to type in more information on scholarships awarded by each club, and adding a request for copies of programs.

I recommend that the cash award for Choral Music be equally divided between the two clubs which have newly-formed ensembles: The Canton Music Study Club of Mississippi and The Melody Club of Dallas, Texas.

From Pennsylvania: <u>Dushore Music Club</u> and <u>Williamsport Music Club</u>



#### **COMPETITIONS AND AWARDS DIVISION REPORT-Milwaukee, WI 2018**

Revisions were made this past year to the Competitions and Awards Chart, and work was set in place for the new online website application process. Chairs were given the option of accepting uploaded application materials or hard copies with the thought that eventually all would be submitted online. Records of problems regarding this process were kept and were addressed by our headquarters staff. The Competitions and Awards Board consists of all NFMC Award Chairmen while the Competitions and Awards Division consists of all award chairmen not included in other divisions, mostly Sr. level competition chairmen. At this year's C & A Board meeting a demonstration on how to deal with online award applications will be presented by Jennifer Griffin. Below are the reports from the Division Chairmen.

Evan Williams was selected as the winner in the Piano Solo Category, Zach Davis won in the Vocal Category, and Charles Peck was the Chamber Music winner. Evan Williams also won second place in the Chamber Music Category

Youse Composition Award-Brenda Lewis, Ch.-No report submitted.

*Mayfield Opera Award-Margaret Ulmer, Ch.*-This Biennial Award will be given again in 2019. Deadline for applications is February 1, 2019.

Ellis Duo Piano Competition-Dr. George Keck, Ch.-The 2019 Ellis Competition will be held on the campus of Belhaven University in Jackson, Mississippi on March 30, 2019. The 2017-19 Ellis Winners, Happy Dog Duo, performed eleven concerts this year for NFMC. *Virginia Allison Award-Kay Hawthorne, Ch.*-There were two entries in this award and the winner was James Maverick from Kansas. Moving this to the Sr. Division was a wise choice as the winner is 27 and the other entry was 30.

Hinda Honigman Award for the Blind-Bobbye Guyton, Ch.-There were no applicants in this award in 2017. Ouida Keck Award-Laurel Ince, Ch.-There were no applicants for this award in 2017. Entries for the 2018 award are not due until June 1.

**Young Artist Presentation-Starla Blair, Ch.**-During the 2017-18 year 18 Young Artist performances and 2 workshops have been scheduled. This brings the total Young Artist appearances for the biennium to 36 concerts and 5 workshops.

#### Annual Report of the NFMC Veteran Awards

In September of 2018 the announcement and descriptions of the three NFMC Veterans Awards were sent via US Postal Service to all known US Armed Forces military bases and establishments having music units. Addresses of the Director/Commander of each unit were obtained from the websites of the various branches of the Armed Forces listing active music units around the globe.

The number of these units has been reduced significantly in recent years as a result of DOD budget cuts. There were additional reductions within the past year, but fewer than in recent years.

Over eighty announcements were sent in September 2017.

The deadline for the 2017/2018 entries was May 1, 2018. There were four entries in the Composition Competition and only one in the Lucile Parrish Ward Competition. The Anne Gannett Award was not offered as it is available only in odd numbered years.

First place in the Composition Competition was won by Bradley Kerr Green of the Air Force Heritage of America Band for his original composition for band titled *Flourish for Flight*.

Second place of the composition competition was won by Edward Knoeckel, a member of the Air Force Band of the West stationed at Lackland Air Force Base in Texas. His composition for band is titled **DOXA**.

The Lucile Parrish Ward Award was won by Bryce Kyle who is continuing work on his music degree after serving in Vilseck, Germany. Bryce plans to work on a Masters Degree as well as a PHD.

The three judges for the Veterans Awards were Dr. Lorrie Crochett, current Head of the Music Department and Director of Bands at Winthrop University in Rock Hill, South Carolina; Dr. William Malambri, retired Head of the Music Department and Director of Bands at Winthrop University; and Dr. Stanley F. Michalski, Jr., retired Emeritus Professor of Music and Conductor of Bands at Clarion University in Pennsylvania.

### Beyer Competition Report to NFMC, May 2018

- 1. This first year of my tenure in this job has been one of learning and exploration.
- 2. I knew from the start that some sort of publicity was needed. I was told that the person who did this job before me had used postcards. I thought a poster that could be distributed at schools to students of composition would be better. I had a design person here in Kent work up a poster, finally got it approved by NFMC, and sent it as an email attachment to a long list I had obtained of professors of theory and composition nationwide. I got numerous thanks from these academics for what I had sent. But I am not sure the poster was used very well—or as I had intended. This step in the process must be done better in the future. I am still skeptical about postcards.
- 3. I am very pleased with the NFMC website and with the capability to upload entries there. That feature of the website works very well. My "mailbox" there contained applications and scores and CD like attachments that were easy for me to download; and then easy to send electronically to my judges. Perhaps in the future the website itself may be used better for the publicity. I hope that last point will be explored.
- 4. In any case, the work that I did receive as entries came mostly from the website and came as electronic uploads to my "mailbox" there. Somehow the bright composers across the country need to be attracted to the use of this website.
- 5. Clearly, the number of entries was a disappointment to me—only five pieces. I was very worried until I got my judges, finally, to work on them.
- 6. My judges were a good friend and colleague here in Kent whom I have known and admired for his own compositions. He teaches theory and composition. The other judge is a Dean in the School of Music at Syracuse University. He has also taught theory and composition. I think their work in reviewing the work was excellent. See the start of my article below sent to the Magazine for further publicity.
- 7. The article indicates how pleased I am finally. This is great work. I hope to continue next year. We must work better on publicity.

### Beyer Competition Awards Three Young Composers By Donald M. Hassler, chair

The great Bernstein, who would be a century old this year and who began to compose early, always hoped for a Classic American Music. Perhaps his hope is still alive and fueled, in part, by the enterprise of NFMC.... Here are the winners that emerged with excerpts of the comments: Evan Williams: piano solo "interesting theory-to-composition reverse engineering" Zach Davis: writing for voice "elegant and touching simplicity throughout" Charles Peck: chamber music "extreme contrast between movements; interesting and effective use of extended techniques and idiomatic writing" [Williams won a second place award here]

Finally, I hope the sentiments and judgements in the longer version of the article that I have shared with the composers and with the judges will help this competition to grow in the future.

Another busy year for the Finance Division. We are still streamlining the finance reporting systems. The treasurer and auditor are in Nashville; our CPA and Executive Director are in Greenwood. The audit was done 5 months earlier than last year, what a difference the revised system made.

Financially, it was a good year. A good relationship has been developed with our new advisor, Wabash Consultants and Fidelity Investments. My thanks to the Investment committee for their work.

Our general fund is in much better shape. Keep in mind that our only revenues are dues, publications, and activity fees.

The President, Executive Director, Budget Chairman. Treasurer and I met in Greenwood during the second week of May to discuss the proposed budget, changes in the duties of the treasurer and future use of earnings. It was a productive meeting.

There are always things that happen that involve use of funds. The only two items this year were a complete carpet cleaning and installation of a garbage disposal. Both were paid for by the building maintenance fund. I must say that the stucco work and outside painting that was done at the end of last fiscal year really look nice. That work was covered by insurance.

Thanks to the New York and Pennsylvania Federations for endowing their scholarships to Chautauqua. They will be listed separately in the C&A Chart. Idaho is in the process of endowing their Comstock award. Ohio and Indiana will be funding their scholarships through their state federations and will not be listed in the C&A Chart. An endowment requires a base amount of \$10,000 before it is listed in the C&A Chart.

Back in 1996, the Neumann estate left NFMC a sum of money that was to be allocated for use for 4 entities: Interlochen Arts Center, Interlochen Summer School, Miami University and the National Arts Club. We are currently in legal negotiations with the National Arts Club over their share of the fund. Hopefully this will be settled by our national meeting in June.

There will probably be a number of changes in our NFMC award amounts. Please read the C&A chart and the application form ach year to be clear on all awards – the amount, the requirements, the deadline and the entry fee.

Thanks to the members of the Finance Division for their service. I appreciate your cooperation in getting our work done.

#### **NFMC Investment Committee Report 2018**

#### Robert J. Coopman, Esq., Chair

Detailed performance data of the investment account will be made available for the committee's meeting in Milwaukee. My back-of-the-envelope calculations are that we have a balance (\$12,096,665 as of 5/21/18) that is 5.05% higher than this time last year (\$11,485,216 on 5/17/17) The exact investment return is different from this since the returns after additions, subtractions and operating expenses and awards will have an impact on actual returns for the investments. However, some observations are possible given a review of some benchmarks.

The portfolio has remained roughly consistent with a 55 % allocation to cash and bonds and 45% equities. The advisor has decided to remain in the more conservative range available in the IPS guidelines and we might like to discuss amending our risk/return profile at our meeting. One thing that hurt the returns was that the bond index was down -3.79% in the trailing 12 months. This index is typically up 4% year-over-year. Foreign developed equities were up 7.2% for the trailing 12 months and the S & P 500 was up 11.72%.

#### TAX EXEMPTION REPORT

### 2018 CONFERENCE, MILWAUKEE, WISCONSIN

The purpose of the Tax Exemption Chairman is to provide simple and cost free IRS 501(c)(3) tax exemption for NFMC regions, state federations, districts, and local clubs. As of May 14, 2018 the NFMC 501(c)(3) Group Exemption includes five Regions, seven State Federations, three Districts, and 114 local clubs. One Region, one State Federation, and three local clubs have been approved since the 2017 Convention. Three local clubs were submitted to IRS and are awaiting approval. The list of approved organizations by state is shown below.

Many donors require that recipients be tax exempt to ensure tax deductibility. There is no cost for obtaining exemption but it does take some time and effort. Clubs are encouraged to start the process before fund raising opportunities are lost due to lack of exemption. In his November, 2015 "Musical Note," President Michael Edwards announced his ONP Award:

Graduating Senior Performance Award: The recipient must be a graduating high school senior who pursues a degree in performance at an accredited music school. Applicants must have earned at least one NFMC Federation Festival Cup by their senior year.

As chair of the ONP Award, I composed another letter to all state president that was sent by Jennifer from headquarters. The request for each state to contribute a minimum of \$250.00 each year of Michael's administration was reiterated in that letter. States can contribute directly from their treasury or designate an event to raise funds for the ONP award. Some other possibilities are:

- to designate the ONP contribution in the honor of a deceased member

#### **Online Festivals Management System**

The summer of 2017 was spent working with three companies who submitted proposals for updating the Online Festivals System. There were extensive reviews of each proposal and interviews with each company viewing current sites developed for other clients. A company was selected and our Executive Committee completed a contract with that firm. A Project Manager has also been selected and is making sure that deadlines are met.

At the upcoming NFMC National Convention in Milwaukee, the new developer will be giving a presentation on the progress of rebuilding the Online Festival system. This session is scheduled to follow the Festivals meeting and will include a peek at the new "look".

For those who will not be in attendance in Milwaukee, status information and a preview of the look of the new system will then be available for viewing on the NFMC website after the convention. This will include "common question" slides for everyone to view.

The project is a complete rewrite of the current system, and will have the following stages.

We do not have specific dates for each section, but here is a list of the basic sections and the estimated tiem frame for each:

- Preparation (completed)
- Project Design, Development and Testing by module (9 months)
- Full System Demo/Review with the core team (2 weeks)
- Pilot Launch or "Alpha Test" to manage actual festivals & provide feedback (7 months)
- Full Launch or "Beta Test" to manage all festivals & provide feedback. The site developers will remain available for at least 18 months after the first festival is run with the new system to help with any adaptations that are needed with real use.

At the present time, the project manager conducts a phone conference each week with the developer of the new system. Depending on the specific topic for the week, certain members of the three committees involved with the project are included in the conference call. These committees are:

- Steering Committee
- Technical Committee
- Practical Committee

These weekly phone conferences make sure that the developer is well acquainted with the needs of NFMC and is understanding the complexities of our NFMC Festivals. We spend a lot of time reviewing the way the current system is working, and what needs to be improved. Bulletin requirements are explained and clarified with reference to specific pages in the Bulletin where the requirements are defined. WE alos spend a lot of time brainstorming about what might be a better way to design the new system so that it will be more user friendly.

There will be no workshop sessions scheduled the day before convention this year (2018). The new online system is not yet developed enough to make hands-on training session on the new site valuable this year. Next year will be a big year. Watch for announcements and opportunities for remote training this year, and we'll feature the new System in topics at the convention in 2019. The new system is slated to have an internal help function that we can all contribute to as we adopt the new tool.

## NFMC JUNIOR COMPOSERS 2018

Baby Dolphin's Lullaby, Hunting Cat, Iconoclasm, Sands of Time. What do these names have in common? They are the first place titles of winning compositions at the National level of judging for this outstanding contest. NFMC sponsors a yearly competition among our Juniors that encourages the composing, notating and recording of their new music. Beginning with the state contests, students are judged using a standard rating form upon which the judge gives encouraging remarks and awards points. Winners were ranked in 1<sup>st</sup> and 2<sup>nd</sup> place however all students could earn points for Federation cups at the state level. Contest fees collected by the state were the only costs incurred by the student. Contest fees and entry deadlines varied by state. Winners at the state level advanced to regional judging. The difference at regional level is that the judge did not make comments, only rankings. The one exception was the Western Region which continued the practice of charging a small fee to have the judge spend time making comments. As the Western chair has stated, this is not always a worthwhile endeavor since a judge can't possibly spend enough time evaluating a score and making comments for the very small amount of money offered. This practice in the Western Region is being re-evaluated for 2019. Our five Regional Chairs obtained judges to rank students that advanced from Regional to National Judging. The National level judge this year was Dr. Frank Felice from Butler University in Indianapolis, IN. He judged 50 scores, spending 30-60 minutes on each one, listening to the recordings, making comments on the prescribed form and ranking the winners. There are quite a few prize money awards given at the national level, which is great incentive for the students. Students at the national level also receive certificates and the judge's rating sheet.

In 2018, scores, recordings and applications were initially submitted online to the state chair, which made it easier to share materials with judges at all levels.

Class 1 (ages 9 and under) - number of participants: 151

Class 2 (ages 10-12) – number of participants: 195 Class 3 (ages 13-15) – number of participants: 159 Class 4 (ages 16-18) – number of participants: 112

Number of students who ended up involved in the national level was 50; 23 received some kind of a monetary award.

Regional participation: NE Region 138; SE Region 296; SC Region 27; Western Region 61; NC Region 95. Total participation was 617 students. This is outstanding!

Many state Federations offer scholarships based on placements in this contest. For example, the seven states of the NC Region offer scholarships for students to attend the Junior Composers Summer Programs composition camps held in Minneapolis every year in July. This program enhances the work students do with their private teachers during the school year. Many times pieces created and recorded during the summer program end up in the JC Contest the following January.

Recently announced winners in the ASCAP Foundation Morton Gould Award included three students who entered our JC Contest. Nathan Paek, Jenny Yo, and Charles Meenaghan were high ranking winners in our contest as well as finalists in the ASCAP Foundation program that honors young composers.

Thank you to the many chairs involved in this contest and for their wonderful volunteer work. Many hours are spent on this contest to make it what it is. We are compensated by the appreciation of participating teachers and students who benefit year after year.





I contacted the entrants via email, along with the teachers, and relayed the results of the competition. I congratulated the winners and thanked and encouraged the 3<sup>rd</sup> entrant who did not win.

I proceeded to submit payment and vouchers for the judges and the winners.

I would like to propose that the requirements for future vocal awards be changed from audio submissions to video submissions and that they be specifically for the purpose of submitting for this competition, rathn than be from a public performance or recital situation. The current requirements state that the pieces are to be performed by memory. There is no way to verify this requirement with an audio recording.



### NFMC's Membership and Education Division One-page report for 2017-2018 Ruth Ann McChesney, Chair

How do **Membership and Education** relate? Apparently we need to "**educate**" the world about what NFMC has to offer and why "**membership**" is worthwhile! We are making progress in some areas but not in others. Senior Membership decreased by 735 but Junior members dropped by 2,924. The Student/Collegiate level lost over 8,000 members; see comments below for that. The Division meeting on June 23, 2017 in Dayton, OH was well attended with 7 of the 8 chairs and about 10 guests. Each chair was given time for comments and highlights, and among important topics were the new Senior Club Reporting forms and a revised Orientation and Leadership Manual.

**Total NFMC membership in 2017-18 was DOWN 11,880 to 121,505.** The greatest loss was in the Junior Division that went from 5,056 clubs to 4,785 and that resulted in 2,924 fewer members. Help!!

**SENIOR EXTENSION:** Numbers are interesting – 12 fewer Senior Clubs resulting in a decrease of 735 members! Getting more members is encouraging but losing that many clubs is DISCOURAGING. In doing some research, there appears to be a great need to be more visible on the internet and on social media sites. That's going to be Ruth Ann's emphasis on President's Day 6/19.

**STUDENT-COLLEGIATE EXTENSION:** It's hard to believe that 33 Federated states have NO Student-Collegiate clubs reported. The good news is that there was only a net loss of ONE club (to 78), but unfortunately, the membership total dropped from 19,103 to 10,925 and Individuals who joined dropped from 80 to 32. Apparently "M.U.S.I.C AGENTS" need to keep finding ways to make the value of NFMC known to college music/drama/poetry departments so that the awards find recipients and those 19 through 25 will get excited about the advantages offered! They are our future! Jan Hill/RAM

**JUNIOR EXTENSION:** Linda Lind reports a loss of 2,924 Junior members and that seems to be a reflection of the loss of several large Associate Clubs that did not renew membership. NFMC headquarters has a plan for next year to have a separate accounting for those Associate members and thus give a more accurate accounting of gains or losses of Junior membership. Unfortunately, there was a loss of 271 Junior Clubs and that means a need to find more teachers who need to know the value of NFMC membership!

**INDIVIDUAL MEMBERSHIP:** This area includes Individuals, Life Members and Cradle Roll which showed a combined loss of 43 (from 477 to 434). Of those enrolled as Individual members, 274 were Seniors. Why not encourage Students, ages 19 through 25, to consider the low-cost Individual membership to qualify them for the many S/C awards and competitions! A Cradle Roll 'gift' is a way to surprise new parents, too! Cynthia Steinbach is the new chair of this area.

**COURSE OF STUDY/PROGRAM PLANNING:** Nothing has changed in the Course of Study area since the book list was updated in 2016 and continues to be more than adequate! Having a "theme" for the year and studying something entertaining and educational is sure to keep attendance steady in a club. Linda Vollen says "Try it; you'll like it"!

**YEARBOOKS:** Patsy Whitaker read and graded each of the 56 yearbooks sent from federated clubs across the USA. (That's 56 out of 572 clubs.... not good). Texas and Alabama count for 31 of those! Yearbooks contain valuable information about upcoming programs, scholarships available, a directory of members and lots

**SENIOR CLUB REPORTING:** New chair, Linda Flick, continued to make revisions to each of the three Senior Club Reporting forms, reminding clubs that ME 7-1 is for the most common club, that of

"Music Appreciation", ME 7-2 is for a senior club made up of teachers, and ME 7-3 is the STATE summary form. Make sure your state has a chair for this division; the form is most valuable.

**ORIENTATION AND LEADERSHIP:** The new and improved *Orientation and Leadership Manual* that Lucinda Lear has revised will be available at the NFMC conference in Milwaukee. Be sure to get your copy! Thanks, Lucinda!

#### NFMC Senior Membership 2017-2018 Report

Numbers are not everything, but it's interesting that with a net loss of 12 Senior Clubs (from 584 to 572) there was a decrease of 735 Senior members, from 15,331 to 14,596. Kudos to Arkansas, Michigan, Georgia and California for the increases they reported! .. And So. Dakota numbers are very confusing with 20 clubs, up from 4 in 2016-17 but only 28 total members. That just can't be. Makes one wonder about our reporting system

There was an increase in <u>Individual</u> Senior members, also, but a small one (from 270 to 274). That makes the **TOTAL Senior membership 14,870.** But what happened to the 12 clubs that dropped out of the Federation? We probably know, just from experience – an aging membership and difficulty in getting officers and leaders. OR is it.... people don't know we exist??

Somehow, Senior clubs need to move into the 21st century with more internet and social media presence. How many have a Facebook page or even have a website?? As an example, I checked one state website and there are 50 Senior Clubs listed. Of those, only 2 appear to have their own websites. In contrast, but still needing improvement, a different state has 12 clubs with websites out of the 21 clubs listed. I scanned a number of other states and found a LOT lacking, from no listings of Senior Clubs to outdated and empty calendars.

#### LETS WORK ON MAKING OURSELVES KNOWN.

I can speak from experience that a great website attracts musicians and music lovers. Check out the Tuesday Musical Club's site at www.tuesdaymusicalclub.org and you will see how/why there are new members in the Pittsburgh area joining every month! Yes, it's TRUE! They have over 200 members.

Let me challenge you to find a way to get your presence known!

Report of the Student/Collegiate Extension for the 2017-18 year and June 2018 Conference in Milwaukee, WI

With "Agents of M.U.S.I.C" all over the country, the Student Collegiate club membership dropped by 8,178 members (and from 80 to 32 Individual members), and yet, overall, **there is only 1** <u>less club</u> **listed.** Figure that out???? Well, here is one explanation: Ohio had a total loss of 7,554 members, BUT had 7 Individual members join!! NFMC headquarters reminds us that most colleges and universities are not reporting accurate numbers for their music programs. Several report only the minimum number (under 50). Bless Ohio for trying to get more accurate numbers, but to no avail at the time of the reporting from NFMC headquarters.

Kudos to Indiana that had an increase in S/C membership from 100 in 2016-17 to 233 in 2017-18. Texas was up 191 members and the great state of Washington went up from 0 to 220 this past year!!

There still remain **10,925 total members** in the 19 through 25 year age bracket and it's great to know that many young people are involved in the Federation in some way. Maybe Michigan did get to add the students studying poetry since they rose from 477 to 553 members total!

Sad to say, there are 33 states with NO Student/Collegiate clubs at all (but 11 of those had one or two Individual members). Surely there are college music departments that would like to be eligible for the many competitions and awards available for students in those states.

C'mon "M.U.S.I.C. AGENTS", get back to work and make NFMC known!! You are "Many United Spreading Information to the Clueless"!!

There were several NFMC activities that were not applicable to MUSIC TEACHING Senior Clubs, and several activities that were not included on the original ME 7-1, so a new report was created specifically for the MUSIC TEACHING Senior clubs. In the process, all three (ME 7-1, ME 7-2, ME 7-3) were given an update. So, I have have reviewed the ME 7-1, ME 7-2, and ME 7-3 forms and have made revisions to each of them with omissions, additions, and new wording to try to make these forms as "user friendly" as possible.

ME 7-1 is the SENIOR MUSIC APPRECIATION Club Reporting Form. A music appreciation senior club is a club with senior members that are not teachers with Junior Clubs. This is basically the same form as it was in the past.

ME 7-2 is the SENIOR MUSIC TEACHING Club Reporting Form. A music teaching senior club is a club with teachers who are senior members with Junior Clubs. This is the new form.

ME 7-3 is the SENIOR CLUB SUMMARY Reporting Form. This is the form you use to compile all of your senior club information from their ME 7-1 and /or ME 7-2 forms.

The ME 7-2 MUSIC TEACHING Form was developed because the original ME 7-1 didn't seem to address some of the events and activities that are most important to the senior teachers with Junior Clubs.

It's fine if your Senior clubs are just sending you ME 7-1 forms, like they have in the past. If they feel that the ME 7-1 meets their needs for reporting, that's great.

The most important form is the ME 7-3 that you fill out and send to me. That's the ultimate report. I have already received a few reports on the above-mentioned forms from Mississippi, Virginia, Oklahoma, and Michigan.

#### **SOCIAL MEDIA REPORT**

Social Media is a great resource for publicity, finding new members and communicating among your members. The best vehicle for publicity is a Page or Place, as members and others can tag your state/club in their personal posts. I was excited to see that we have 1 region (Southeastern) and 21 states using this avenue. (AL, FL, GA, ID, LA, MI, MN, MO, NJ, NM, NY, OH, OK, OR, PA, SC, TN, TX, VA, WA, WI). It's a little harder to find all the local club pages, but did find a few local club pages of the states that didn't have their own (Lawrence Music Club in Kansas, Rossini Music Club in Maine, Greenville Women's Music Club & Fortnightly Musicale of Tupelo in Mississippi).

The other tool is using a Group. Often times, a group is more likely to show up in the newsfeed – while a page is less likely. They have Public, Closed and Secret Groups. The nature of our organization would be best served as Public (with a publicity focus) or Closed (better for member communication). One region is utilizing the closed group (Western region). I found 8 states with groups, closed or public. (AL, AZ, AR, CO, FL, GA, IA, MO) Again, I found a few local clubs when searching for the states that didn't have anything: 8N Indiana FMC, MacDowell Music Club of Statesville in NC.

Just like with websites, they are most effective when they are used and updated regularly. Some of the best content for the "About Us" can be found on your website. Also, I hope that states and clubs will create events of their meetings, so that members can invite others. Then, post pictures during the event! Even better, if your event doesn't involve ASCAP materials/music, why not do Facebook Live! It is a great opportunity for more members to share in what you are offering – at the time or watching the recording.

When creating posts on your page and in your group, using pictures/clip art and hashtags can increase your visibility. If you are needing ideas for content, how about promoting our many NFMC awards? We are coming up on our Biennial – offering many national award opportunities. Wouldn't you like to have a winner from your area?

As our society continues to get more and more technology and social media focused, this is among your best tools for finding new members. I hope to have even more states next year. I would like to know even more about local clubs that are involved on Facebook – so please invite me. I am always willing to help get you set up. Milwaukee, 2018

We were given special mint-laden "phones" and told we were "mint" to infiltrate colleges, universities, conservatories, etc. with our message: Our Federation has awards to give to worthy musicians between the ages of 19 and 25.

Another Conference is upon us, and another opportunity affords itself to spread the word! This year the Student/Collegiate Division will present a new message to the state presidents...and to the conference attendees...that there's **GOLD** to be found in NFMC!

During our Student/Collegiate Division presentation to the state presidents, one can expect some gifts and some surprises! We will be introducing a special guest, "Clementine," who will help us "mine" the "NFMC GOLD."

Some examples of "nuggets" that were found this last year:

Past National President Carolyn Nelson Double Reed Award chair, Tim Baumann, presented oboist Russell Hoffman with \$1200 as the first-place winner. Russell was born in Morristown, NJ, and attends the Julliard School of Music. Second-place winner, Brianna Rife, a sophomore at the University of Tennessee (Knoxville) studying bassoon, won \$500.

"Clementine" will discover that some awards, such as the Student/Collegiate Auditions prizes, are given biennially, meaning that they were not given out during 2018. Therefore, some of our chairs have been spending this year laying groundwork for next year.

Unfortunately, there were some awards that went unclaimed this year. # MUSIC THERAPY AWARDS 2018

Applications were received, organized and presented to three judges in the Music Therapy Department at Florida State University. The following winners were selected:

The NFMC Dorothy Dann Bullock Music Therapy Award of \$1400 was awarded to ANNEBEL LEIGH ROBERSON, a senior at the University of Alabama. She is the daughter of Susie and Barry Roberson of Brentwood, TN. A graduate of Brentwood HS, her principal instrument is the trumpet, but she also has proficiency in piano, guitar and voice. The trumpet section leader in the Million Dollar Marching band, she also plays in Pep bands for various sports. She serves as Treasurer of the Capstone Music Therapy Association. This year she has designed and implemented her own research study evaluating the thoughts and attitudes of music faculty and staff towards music therapy to identify opportunities for advocacy within the school of music. She will present results of this study at two university conferences as well as the Southeastern Region American Music Therapy Association Conference. She is also investigating music therapy and Medicaid reimbursement in Alabama, Tennessee and Texas.

She has worked with a wide variety of client populations and settings. Some of the facilities to which she has taken music therapy are: summer activities for children in a church setting, psychiatric inpatient care facility, neonatal unit at DCH Regional Medical Center, Speech and Hearing Center, RISE school for infants to 4-year olds with various disabilities, a day program for adults with autism, an inpatient facility for cancer treatment to assist patients in relaxation, elevate mood, decrease depression and increase quality of life during treatment, a day facility serving adults with disabilities, a transition program for students 18-21 with developmental disabilities, at Tuscaloosa County High School with a choir of typical high school students and students with various disabilities, in a day program for adults with Alzheimer's and other memory disorders, at an outpatient education center for children with developmental and emotional/behavioral disorders, and at the Joseph School in Cabaret, Haiti.

Annie worked as the web and marketing consultant to a Nashville catering company while in high school and started her own business Roberson Virtual Solutions. She offers web development, social media marketing, and digital marketing consulting to bloggers and small businesses. Even with all this, she maintains a 3.93 GPA. A Presidential Scholar, she was nominated for most outstanding Senior in the School of Music.

ABIGAIL LEIGH PARRISH, was named the winner of the NFMC Ruth B. Robertson Music Therapy Award of \$500. A sophomore at Converse College, she is the daughter of Joey and Timmi A. Parrish, of Roebuck, SC. A graduate of SC Governor's School for the Arts and Humanities in Greenville, SC, she is proficient in piano, guitar and voice. Abby grew up singing in the church choir with her grandparents. She has been a part of both ACDA South Carolina and national honor choirs since fifth grade. While in high school, the group gave concerts in Germany, Austria, Prague, and toured historically significant sites pertaining to their ancestors in classical music. She sang in a quartet with NPR's "From the Top" program.

Abby's Father is a bassist in a southern rock band and exposed her to music at an early age. While a member of Converse Chorale, they received a grant to give a concert for the community alongside residents of an assisted living facility. They were paired with different residents, and partners would connect with each other before and after rehearsals and at post-performance reception.

Abby plans to continue education toward a doctoral degree and perhaps teaching at the college level. She says her need is greater this year than in the past, due to her father's recent unemployment.

To quote Abby: "Music is the basis of all of my relationships and is the driving force behind everything that I do. It has carried me through struggles in life – loss, divorce of my parents, my father's recent unemployment, as well as my successes. It has given me the strength to face all things with courage as well as to do great things EVERY SINGLE day! My wish is for music to touch the lives of others like it has touched mine. I truly believe in the power of music, not just in the emotions, but for the processes of the mind and for the body itself. The evidence is there and it's unbelievable."

The **NFMC Irma Carey Wilson Music Therapy Award** of \$500 was awarded to **MAGGIE CLAIRE SHORTER**, a sophomore at the University of Alabama. She is the daughter of Susan and Richard Shorter of Eufaula, AL. A graduate of Eufaula High School, she is proficient in flute, piccolo, piano and guitar. In High School she was selected for All-State all four years, and also competed in the Solo Competition as well as many symphonic and marching honor bands. She was also a performing member of jazz and show choir bands, playing bass guitar. Academically she was salutatorian, active in the National Honor Society and competed athletically on the crosscountry team. She was also involved in church and youth groups.

When she was in 9<sup>th</sup> grade, her grandfather suffered a stroke and was sent to a nursing home for therapy and rehab. She visited him often and would play the flute. He was so happy to listen that she was encouraged to play in the common room for all the residents. They would come and listen and tap their foot and ask for more when she finished. Seeing what music could do in situations like that is what ultimately led her to study music therapy.

Since being at the University, she has attended flute master classes, entered solo and chamber competitions, is secretary of the UA flute club and played piccolo in the top wind band at UA. She has had clinical experience with a short-term facility for children with emotional/behavioral disorders. Another experience was with an adult day care for individuals with Alzheimer's and dementia. A typical session involves several songs led on guitar, upper and lower movement to songs and rhythm to songs. Still another setting is a facility that helps college age individuals with intellectual developmental disability transition into independent living. She is currently observing at the Pediatric unit at DCH Regional Medical Center where goals are usually normalization, relaxation and distraction. The kids are happy to see the therapists come with their books and music and it offers a break to the parents while therapists keep the child occupied. She has also been involved in programs at ARC, a facility for adults with IDD, at a psychiatric branch of DCH and at Hospice of West Alabama.

Maggie says she has learned time management skills and has worked hard to keep grades up and make the Dean's list every semester so far. She adds, "Scholarships are a great assistance in helping me afford these amazing opportunities at the University of Alabama."

Winners have been notified and forms have been filed with Budget Chairman and NFMC Treasurer to complete payment to the winners of the awards. All three judges declined to accept payment and requested that funds be kept in the Music Therapy fund.

Articles about all winners (with a picture) have been submitted to *Music Clubs Magazine*. Chairman has informed presidents of each of the states (their home state, and the state where they attend school) of the winner's names.

The first prize winner was Russell Hoffman of the Julliard School of Music and the second prize was awarded to Brianna Rife of the University of Tennessee. Biographies of both prize winners are included below. The submission date for the 2019 Carolyn Nelson Award for Double Reeds will be March 1, 2019.

Oboist Russell Hoffman has performed with many leading professional orchestras including the Metropolitan Opera, New York City Opera, New York City Ballet, and the Pittsburgh Symphony Orchestra, where he was a finalist for the Associate Principal Oboe position. Currently an undergraduate student of Nathan Hughes at the Juilliard School, he will continue his studies next year with Richard Woodhams at the Curtis Institute. He previously studied with Richard Dallessio in the Juilliard School Pre-College Division, from which he graduated in 2014 with the school's Achievement Award, and where he served as teaching assistant from 2014-2017. In past seasons, he served as Principal Oboe of the New York Youth Symphony, was named a 2014 National YoungArts Foundation Winner, and appeared as soloist with the Summit Symphony (NJ) as the winner of their Young Artists Competition.
