

We hope to highlight some compositions in the new 2024-2028 Festival Bulletin and present ideas to inspire and ignite interest in repertoire. Our Festival Chorus director, Dan Andersen has ideas to help our voices age better and continue singing throughout our life!

You'll enjoy special performances by our NFMC Young Artists on Wednesday evening and performances by some of our award winners as Musical Moments are sprinkled throughout our meetings. The Bix Beiderbecke Museum is located in downtown Davenport and the director of this museum will share more insight into the world of jazz in the 1930's at our Rose Fay Thomas luncheon along with a pre-luncheon concert by a small jazz combo.

Thursday evening is a special Iowa treat. We will journey a few blocks down the street to Asbury Methodist church where is housed an historic Pleyel Double Grand piano, the only working piano of its kind in this hemisphere. The Happy Dog Duo enjoyed playing on this unique instrument at the 2019 Iowa Conference and we are thrilled to have them back bringing humor and joy to classical music! BUT FIRST—we will enjoy an Iowa hog-roast (well, we won't actually roast a pig) supper at the church with smoked pork or chicken, baked beans, coleslaw and all the trimmings needed for a summer night's picnic in Iowa.

The final concert on Friday will be an extra special presentation by Audrey Johnson entitled "We've Come a Long Way, Ladies! A Musical Celebration of the 19th Amendment." This program brings the Women's Suffrage Movement to life through historical music, projected images, onstage costume transformations, a spoken narrative, and audience participation.

The Channel Cat Water Taxi will help you explore the Mighty Mississippi without the need to drive. It stops at 4 different landings including the Village of East Davenport where you can walk the streets and shop the Unique and memorable Isabel Bloom sculptures are boutiques. handcrafted in Davenport. Then perhaps continue on to the John Deere Commons Landing. The John Deere Pavilion is an attraction and museum located in Moline, Illinois that details and highlights the beginnings of one of the leading tractor companies in the world. In Davenport, visit The German American Heritage Center & Museum, located in a former hotel that hosted thousands of immigrants in the 1860's. This museum details German immigrants' journeys by sea, train, and foot to Iowa. Also in Davenport is The Figge Art Museum, a landmark glass building on the banks of the Mississippi River with expansive galleries and a premier art exhibit and education facility. If you are a Civil War history buff, you may want to find your way to The Rock Island Arsenal Museum in Rock Island, IL. This island was the home of Fort Armstrong, a Civil War Prison, and a mighty armaments hub. Today it is an essential part of Quad-Cities manufacturing and employment.

# BYLAW PROPOSAL 2024 NFMC NATIONAL CONFERENCE

### CURRENT BYLAW (with proposed deletions)

Article III, Section 4 - STUDENT/COLLEGIATE MEMBERSHIP -S/C members must have reached the 19th but not the 26th birthday.

Article III Section 4A STUDENT-COLLEGIATE MEMBERSHIP may be either organizational or individual.

1. Organizations. Organizations whose members must have reached the 19th but not the 26th birthday, including cellego music groups, music schools, music departments, peetry groups, dance groups, choirs, bands, orchestras, and similar music organizations shall be oligible for memborship upon payment of dues as provided in the NFMC Standing Rules and Procedures.

2. An Individual Student may become a Student/Collegiate Individual Member upon the payment of dues as provided in the NFMC Standing Rules and Procedures.

### **PROPOSED BYLAW AMENDMENT**

Article III. Section 4 - STUDENT/COLLEGIATE MEMBERSHIP -S/C members must have reached the 19th but not the 26th birthday.

Article III Section 4A STUDENT/COLLEGIATE MEMBERSHIP may be either organizational or individual.

**±**. Organizational: <u>Student/Collegiate Mass Enrollment Membership</u> College and/or university, music-groups, music schools, music departments, which may include but not be limited to poetry groups, dance groups, choirs, bands, orchestras, and similar music groups organizations whose members must have reached the 19th but not the 26th birthday shall be eligible for membership as Associate Organizational members through <u>S/C</u> <u>Mass Enrollment</u> upon payment of dues as provided in the NFMC Standing Rules and Procedures.

2. An Individual Student may become a Student/Collegiate Individual Member upon the payment of dues as provided in the NFMC Standing Rules and Procedures.

**CURRENT BYLAW** (with proposed deletions) ARTICLE III SECTION 6. ASSOCIATE GROUPS

A. ASSOCIATE ORGANIZATIONS. Organizations encompassing all age groups formed for the purpose of promoting a specific music project, such as community choral societies orchestras/orchestra associations, opera companies/opera guilds, music teachers' organizations, local alumni chapters of music fraternities or sororities, church choirs/ orchestras/bands, hand bell choirs, school bands, orchestras and choruses, groups dedicated to the promotion of a concert series in their own comunity, and similar music organizations shall be eligible for membership upon payment of dues as provided in the NFMC Standing Rules and Procedures.

#### Section 6A1

Currently there are no federated S/C active organizations/clubs (as described in <u>current</u> Article III, Section 4A1). These proposals remove the obsolete <u>single</u> organization/club membership option and the <u>Associate</u> mass enrollment option, replacing them with<u>one</u> S/C Mass enrollment option which clarifies the process and meets the organizational needs of colleges and universities.

**CURRENT BYLAW** (with proposed deletions) Article III. Section 8B TERMINATION OF MEMBERSHIP

B. FORFEITURE: If dues are not received for Senior Organizations, Senior Individual, Senior Associate Groups, Student/Collegiate Organizations, Student/Collegiate Individual or <u>Student/Collegiate</u> Associate Groups by the December 1 deadline, members shall be considered delinquent.

### PROPOSED BYLAW AMENDMENT

Article III. Section 8B TERMINATION OF MEMBERSHIP B. FORFEITURE: If dues are not received for Senior Organizations, Senior Individual, Senior Associate Groups, Student/Collegiate **Mass Enrollment** Organizations, **or** Student/Collegiate Individual **members** or <u>Student/Collegiate\_Associate\_Groups</u> by the December 1 deadline, members shall be considered delinquent.

Rationale: Under Article III Section 8B FORFEITURE, the term Associate group is incorrectly described as "Senior". The S/C **Mass Enrollment** replaces "S/C Associate Groups" as addressed in the preceding proposal.

### 2024 Proposed Bylaw Amendment

Bylaw VIII ELECTION OF DIRECTORS AND OFFICERS Section 5F. OFFICERS The newly elected Board (the State Representatives, the Past National Presidents, and the newly elected Board Members-at-Large plus the President, shall meet with the outgoing or incoming State Presidents...to elect a President, a First Vice President, five Vice Presidents in charge of Regions, a Recording Secretary, and a Treasurer.

A quorum shall be established and a majority vote shall be required for election of officers. The elections shall be by ballot if there are two (2) or more nominees...

Rationale: This proposal is to clarify (1) NFMC voting tradition for election of officers and (2) to adhere to Robert's Rules of Order which state "When a quorum is present, a majority vote (i.e. a majority of the votes cast, ignoring blanks), is sufficient for the adoption of any motion that is in order except those (Listed on page 162) which require a two-thirds vote. A plurality never adopts a motion or elects anyone to office, unless by virtue of a special rule previously adopted. <u>The New Robert's Rules of Order Revised Edition</u>. Barnes & Noble Books, New York 1993. Article VIII, VOTE, p. 147.



# Writing an article - this may help!

The NFMC would like to hear from members throughout the country. Why?

It allows the NFMC community to share in the experiences that are going on throughout our organization. A bonus is that you may inspire, encourage, and celebrate with our readers. A few areas may stump or discourage you from writing an article, but I encourage you to write the article and send it in!

### HERE IS SOME INFORMATION TO GET YOU STARTED -

Getting started is usually the most challenging part of putting an article together. You may need help organizing your thoughts and/ or deciding what to write about and share. Following a few simple steps can streamline the process. With the right strategies, you'll create well-written articles in no time.

Subject or topic

Who is your audience?

What do you want to communicate?

The critical point is that it can be about any topic, from current events to personal experiences. The intention is to inform, educate, or entertain your reader. So, to reiterate –

Organize your thoughts

Understand your audience

Build a structure

- 1. Title: you want to make the reader want to learn more about your topic or subject.
- 2. Introduction: present the topic and summarize the main points
- 3. Body: tell your story
- 4. Conclusion: summarize the content
- 5. Refrain from editing as you write; that may break up the flow of your article. Let it flow; editing comes later.

### **SUBJECT OR TOPIC:**

This may be events, fundraising, entertainment, board of directors/ leadership news, enrichment classes or legal seminars offered, or continued education; these are just a few examples.

### **TARGET AUDIENCE:**

Are you reaching out to the membership or the music community? Nonmusical members, teachers, leadership, local to communities throughout the states?

### **RESEARCH:**

Research your story to create trust.

### **OUTLINE:**

Write the outline to get organized.

### **ROUGH DRAFT:**

This is where you write or type. A great thing to add to your article is a quote from someone in the article. If it is an event, add a quote from you, the writer, or an attendee.

### **CREATE SUBJECT CONTENT:**

Grab the attention of your audience with relevance. Drive the article with action and curiosity.

Read over your work, correct it, or reorganize it until you feel it is good. Please share with friends for errors or suggestions. You can count on the editor to do minor edits, restructure as needed.

Within our national organization, there are few times that we are physically together. Connection is so important within our membership. Staying in touch to share, encourage and educate can be done through our magazine. I appreciate being able to help contribute to our national communication. Take the time to share with us and send in your news articles.  $\checkmark$

# **IMPORTANCE OF MEETING MINUTES**

### Every organization, regardless of its size, should compile a record of its actions and accomplishments. Organized groups should document motions, reports given, actions taken, and votes cast.

*I recommend you take care of the minutes; for hours, they will take care of themselves. --- Phillip Dormer Stanhope, 4th Earl of Chesterfield* 

Minutes are the official written record of the proceedings of a meeting of a deliberative assembly, and as such, they serve several important purposes.

The most basic purpose is to inform absent members of what transpired at a meeting and to refresh the memory of those who attended a meeting. The minutes also are a record of the organization's history.

For incorporated organizations, minutes are legal records and may be used in court proceedings if a lawsuit is brought against an organization. Minutes can be subpoenaed, so learning what they should contain to protect the organization is essential. The legal importance of minutes may be substantial if anti-trust, tax advocacy, or other legal issues are raised in a lawsuit or some other context.

For example, the ABC National Musical Association created detailed meeting minutes for its board of trustees for many years. The quarterly meeting minutes included motions, comments made during the discussion, the reasons for making decisions, personal opinions, and even casual comments made by staff, attorneys, accountants, and other consultants hired periodically by the association.

Even though the association was doing nothing illegal, it was investigated and sued for an alleged violation of anti-trust laws. Even though the Association was not found to be in violation, it still had to spend an enormous amount of time and money defending itself. The area that caused the most significant problem was unnecessary information included in the written minutes.

Recorded actions may demonstrate that an organization operates within or outside its tax-exempt purposes. For a nonprofit entity, acting outside the scope of its tax-exempt purpose may lead to a loss of exemptions.

On the other hand, minutes that are written correctly protect the organization. In one case, a member sued after being removed from membership for violating the organization's rules, and the minutes helped to prove the organization had acted appropriately. There were no side comments or personal opinions in the minutes or other organizational documents. Only the process and action taken were recorded.

All this leads to the matter of how detailed minutes should be. Minutes should not include one word more than is absolutely necessary. What is necessary includes well-written documentation that a board or organization is fulfilling its fiduciary responsibilities and that the organization is complying with tax and legal requirements. In minutes, less is more.

Some organizations find it helpful to have legal counsel review minutes before they are distributed to ensure no liability is created for the organization.

Accountants and auditors refer to minutes when performing an audit of the organization's financial records and determine if proper authorizations were given for the expenditure of funds.

Members of an organization have the right to examine the minutes of the organization at a reasonable time and place at the convenience of the secretary. The secretary cannot deny this right to any member. The same principle applies to minutes of boards and committees. The minutes of these bodies are accessible to members of the board or committee but not to others. The right of an organization's members to read or review minutes does not apply to board minutes unless the board permits members of the organization who are not board members to do so. By a two-thirds vote, the organization may require that the minutes or portions of the minutes be read to the assembly.

When the organization writes its history, the minutes of meetings are usually the first and primary document used as a source. The minutes provide the documentation of all the official actions of the society.  $\checkmark$ 



Anthony Turner, baritone, has been presented extensively throughout the United States and Europe in solo recitals, concerts, and opera, and musical theatre performances.

His performances include the world premiere of Mr. Turner's commissioned song cycle *Who Am I*?,

based on the book The Gathering by Jeannine Otis and set to music by Mary Carol Warwick. The New York premiere was presented at LaMama Theatre in New York City. Mr. Turner recently performed Who Am I? at the National Portrait Gallery in Washington, DC. Other performances include the recital 'Poets of the Harlem Renaissance; on the Music at St. Alban's Concert Series; 'Summertime Living: Easy, Poignant Clever and Fun,' at the Piano Performance Museum Festival in Hunter, NY; 'Katrina Ballads,' by Ted Hearne (New York, Houston, Piccolo Spoleto); the premier of 'Shikoku Postcards,' written for Mr. Turner by Houston composer Mary Carol Warwick and performed with the Greenbriar The consortium; a concert version of Kurt Weill's 'Lost In The Stars,' with Holy Apostles Community Chorus (NY); recitals in New York and Boston, Weekend of Chamber Music series (NY); the premier of 'Even This Paradise,' by New York composer Andrew Sterman, performed with the Musical Chairs Chamber Ensemble at the Tibetan Museum in Staten Island, NY; 'Sound + Vision: At War,' a Fusion Bande collaboration at John Jay College (NY) combining the music of Johann Sebastian Bach with the photography of Pulitzer Prize-nominated photojournalist Chris Hondros, and the recital series; 'Music at the Music House' in Greenville, NC.

He has sung the roles of Tony Esposito in *The Most Happy Fella* by Frank Loesser with Wagner College as guest faculty artist; Clarence Thomas in *Clarence and Anita* by New York composer Ben Yarmolinsky with Underworld Productions; Josh Gibson in scenes from *The Summer King* by Daniel Sonenberg with American Opera Projects; and the role of William Henry in *Harriet Tubman* by Leo Edwards with Opera Ebony. Other credits include Harry Easter in *Street Scene*; Alfio in *Cavalleria Rusticana*; Dappertutto in *Les Contes d'Hoffmann*; Schaunard in *La Bohème*; Dr. Falke in *Die Fledermaus*; and Guglielmo in *Così fan tutte*. Mr. Turner has made appearances with Four Season's Arts, Inc. (CA), Opera Exposures (NY), Reno Choral Society (KS), Boston Musica Viva, United States Army Band (NE), Musical Chairs Chamber Ensemble (NY), the recital series of St. Alban's and Serenade (NY) and St. Luke's (MA), and with Opera Ebony (NY) in a program of negro spirituals at the Metropolitan Museum of Art and at the New-York Historical Society in affiliation with its' exhibit, New York Divided: Slavery and the Civil War. Other engagements have included: featured soloist in No Cowards In Our Band with Opera Ebony at the Cyclorama and Civil War Museum in Atlanta, GA, featured soloist with the Dance Theatre of Harlem production St. Louis Woman at the Kennedy Center for the Performing Arts, touring the United States and Europe with performance artist Laurie Anderson in Songs and Stories from Moby Dick featured guest on the PBS special GREAT PERFORMANCES series Aida's Brothers and Sisters: Black Voices in Opera, and featured soloist with Jessye Norman in a benefit concert for the Healing of AIDS, directed by George C. Wolfe and presented by The Balm in Gilead, Inc.

He is an exponent of the classical repertoire of music by black and minority composers, a literature which is consistently included in his concert repertoire. Orchestral appearances include Orchestra of St. Luke's (NY); Evansville Philharmonic Orchestra (IN); Lincoln Chamber Orchestra and the Omaha Symphony (NE); Cincinnati Symphony; Phoenix Symphony; and the Walla Walla Symphony (WA).

Mr. Turner has worked with the conductors Jesus Lopéz-Cobos, David Stern, Giovanni Reggioli, Henry Janiec, Robert Moody, Steven Osgood, Bruce Hangen, Lt. Col. Craig Jessup, Kenneth Hamrick, Yaakov Bergman, Richard Pittman, Jack Eppler, and Ted Hearne.

He has appeared at the Piccolo Spoleto Festival (SC), Opera Theatre di Lucca (Italy), Next Wave Festival (Brooklyn Academy of Music, NY), Barbican Music Festival (London), and the Kennedy Center for the Performing Arts.

His awards and honors include first prize in the National Federation of Music Clubs competition; recipient of *Premier Grant* from the Council on the Arts & Humanities for Staten Island (COAHSI) for his lecture/ recital program entitled **Building Bridges**, North, and South: The Negro Spiritual; Wagner College - *Dr. Martin Luther King, Jr. Agent of Change Award*; *Dedication To The Arts Award* presented by the National Council of Negro Women, Inc., North Shore – Staten Island Section; and named Staten Islander of the week by NY1 News for his volunteer work at the Arthur Kill Correctional Facility.

Mr. Turner received his Bachelor of Music degree in performance from Simpson College and his Master of Music degree in performance from the University of Cincinnati College-Conservatory of Music. In addition, Mr. Turner maintains a private voice studio in New York City and is an Adjunct Professor of Voice at Wagner College on Staten Island.



Traditionally the free will offering at this service is given to a local charity which this year is our local American Rescue Workers. Over \$1400 was generously given this year.





On Friday morning April 28, the Chaplain led a memorial service, remembering all those VFMC members who had passed during the 2022-23 year, as well as those who passed during the Covid time period and had not been honored during the gap in Conventions. The 23rd VFMC past President, Mrs. E. Keith (Mary Ruth) Chambers, passed away this year; the current President honored her by lighting her candle.

After the morning business meeting, members attended the Awards Luncheon, honoring VFMC Past Presidents and Nancy Hoback Milne Citation Winners. The NHM Citation is given for outstanding service to VFMC. Past President Dr. Elaine Brady was awarded the 2020 medal, District Director Judy Barger-Edgell was awarded the 2021 medal, "worker bee par excellence" Marlene Braun was awarded the 2022 medal, and Finance Chair/NFMC Board Member-at-Large Wendell Anderson was awarded this year's 2023 medal. Following the luncheon, members enjoyed a swinging and enthusiastic program by the Northside High School Jazz Band. The afternoon business meeting concluded this year's business with the biennial election, unanimously re-electing the proposed slate of officers: Dr. Cheryl Brown, President; Kathryn Peters, 1st Vice President; Judy Barger-Edgell, 2nd Vice President; Lisa Thomas, 3rd Vice President; Elizabeth Kennedy, Recording Secretary; Elin Havrilla, Corresponding Secretary; Lana Bailey, Treasurer; Dr. Zuill Bailey, Assistant Treasurer.

In the evening, attendees dressed in their best 1920s era outfits for a semiformal banquet, with styles ranging from elegant early 20s Gatsby looks, to mad-cap late 20s flapper and mobster fashions. Vivian Jiany provided a harp interlude as guests gathered, and then diners were seated as the officers and honored guests processed in. Master of Ceremonies Paul Brady entertained everyone with quips and witticisms, and National Guest Deborah Freeman spoke on the Power of the Federation. Then she installed the officers. After the banquet, attendees moved into the salon for a soaring concert by Shaina Martinez, soprano, NFMC's 2021 Young Artist Winner, accompanied by Judy Clarke on piano. Attendees, guests, and performers mingled in the foyer afterwards at a reception in honor of the National Guest and the Young Artist.

The next morning, Junior finalists from all over the state arrived in Norfolk for the finals of the Mary Smart Scholarship Competition, ably run by Marcia Chaplin, state Mary Smart chair. The day concluded with a final concert by the winners in each category.
